

# CLAUDE PEPPERAND CRIME PREVENTION: A GUIDE TO SELECTED MATERIALS IN THE CLAUDE PEPPER COLLECTION

Florida State University Libraries

To gain a clearer understanding of criminal activities and to determine what new federal legislation might be needed to curb them, Claude Pepper in 1969 successfully proposed the establishment of a House Select Committee on Crime and was appointed its chair. The Committee lasted until 1975, conducting hearings in all parts of the country and gathering information on organized crime, street crime, white-collar crime, drug smuggling crimes against the elderly, drug use, and much more. One of the Committee's most famous activities was its interview with Frank Sinatra concerning his alleged connections to organized crime. In addition, the Committee was the first to recommend that the use of marijuana be treated as a misdemeanor rather than a felony. It also demonstrated that the problem of teenage drug abuse was not confined to the large urban centers but existed in small and medium-sized communities across the nation. Pepper was instrumental in investigating the Securities and Exchange Commission for security fraud, in appropriating funds for the Federal Aviation Agency to install metal detectors in airports, and in investigating prison riots after the Attica "uprising" in 1971. This guide will help researchers locate selected resources in the Claude Pepper and Robert Manning Strozier Libraries documenting Claude Pepper's efforts in the battle against crime.
